Credit conditions:

The final grade is based on the sum of the following components:

- (1) presentation of a scientific article (empirical research) during seminars (max. 8 points)
- (2) active participation in discussions during seminars (max. 5 points)
- (3) working on a group projects during classes (max. 12 points)
- (4) written credit: test consisting of 30 questions (max. 30 points) and two open-ended/problem-based questions (max. 20 points).

The maximum number of points to be collected by a student from the whole course (seminars + classes + written credit) - 75 points. To pass the course student has to collect 60% of the maximum number of points (i.e. 45 points).

Grading scale:

45 – 51 points --> 3.0

51.5 - 57 points --> 3.5

57.5 - 63 points --> 4.0

63.5 - 69 points --> 4.5

69.5 - 75 points --> 5.0
