The final grade is based on the sum of the following components:

- (3) working on a group projects during classes (max. 12 points)
- (4) written credit: test consisting of 30 questins (max. 30 points) and two open-ended/problem-based questions (max. 20 points).

The maximum number of points to be collected by a student from the whole course (seminars + classes + written credit) - 75 points. To pass the course student has to collect 60% of the maximum number of points (i.e. 45 points).
